- 1. Call to Order Kneibel called the meeting to order at 3:24 pm
- 2. Roll call John Kneibel, Bob Wittmann, Larry Jaeger (absent)
- 3. Agenda approval Motion by John second by Bob- approved 2-0
- 4. Review of Active Projects List.
  - A. Aquatic Plant Management (APM) grant project. Stakeholders Survey Review Team met informally in person with Todd Hanke of Onterra to discuss how known and unknown lake information has been shared with the stakeholders and plans for designing the APM plan in the coming weeks in preparation of submittal to the DNR. Next meeting with Todd virtually Wednesday May 28th 4pm
  - B. Purple Loosestrife herbicide spraying bid from Abbey Voight to be researched further by Wittmann and Kneibel.
  - C. Dam Maintenance-on going. Permission of land owners completed. DNR representatives Brenda Nordin and Claire Hetzel authorized a maintenance clean up. Weed pulling to begin soon by Sportsmen's Club volunteers.
  - D. Fish Planting-WPLSC. Fish Survey ongoing this spring -Chip Long
  - E. Kiosk installation at Brad's complete. Lock has been replaced. LD Information; meeting Agenda's, minutes, etc. regularly updated. Williams and Wittmann
  - F. Website timely updating with Tim Szczepaniak taking over as website coordinator
  - G. Zoom set-up for District quarterly meetings established by commissioners.
  - H. EWM eating weevils Kneibel, Wittmann to research further.
  - I. Audit end of 2024 with an independent CPR. Jaeger will contact a source for information and pricing.
  - J. Water Survey On Going with WPLMC funds until District budgeting permits.
  - K. Proposed projects Clean Boats Clean Waters, Fish Lake Structure, Muck, acquiring oxygen meter, EWM weevils, Watershed and Wetlands listed as research categorizing.
